### Water Systems Inspector I / GIS Tech

Del-Co Water is a non-profit cooperative water utility headquartered in Delaware, Ohio. Del-Co provides water utility services to over 45,000 customers in Delaware County, Morrow County and portions of five other counties in Central, Ohio. This is a full time position working M-F 8:00 am to 4:30 pm

**Area of Responsibilities:**

Responsible for observing the installation of new water lines and other facilities to ensure conformance with Del-Co Water construction standards, conducting inspections of backflow prevention assembly installations for conformance with state law and company standards. Other major areas of responsibility include operating global positioning systems (GPS) equipment, performing quality control of GPS data, entry and basic mapping in the company's Geographic Information System (GIS), and performing backflow surveys.

**Essential duties:**

Inspect the construction of water facilities. Witness pressure testing of water lines. Flush water lines and pull samples for water quality testing. Check for proper operation of distribution valves and piping. Update field water facility location as-built and mapping information. Conduct backflow inspections on new and existing facilities. Review construction drawings. Maintain construction records and documents and attend construction meetings. Answer basic questions by contractors and developers regarding Del-Co Water construction standards and procedures. Perform initial and follow-up surveys of commercial properties, properties with wells, or other auxiliary water system. GPS field collection of water system asset locations and attributes. Properly compile, track, store, update, organize, and present Engineering and GIS information. Perform other duties as assigned.

**Qualifications:**

Any combination of training and work experience, which indicates possession of the skills, knowledge and responsibilities listed. Must have excellent communication skills, and be able to interact on a professional level with contractors, developers, and homeowners. Must be able to comprehend and understand engineering plans and schematics. Experience with GIS, waterline construction, and GPS data collection highly preferable. Experience in AutoCAD desirable. Must be detailed orientated and well organized. Must be proficient in Windows and Microsoft Office. Possess an Ohio Water Distribution I License and Backflow Certification or ability to obtain within

two years. A high school diploma or GED is required. Must possess a valid State of Ohio Motor Vehicle Operators License, and have an acceptable driving record. Must be able to perform manual labor and work in adverse weather conditions.

**Physical Demands:**

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform essential functions.

While performing the duties of this job, the employee is frequently required to stand; walk; use hands to finger, handle, or feel; reach with hands and arms; talk and hear. The employee is occasionally required to sit; climb or balance; and stoop, kneel, crouch, or crawl. The employee must regularly lift and/or move up to 10 pounds, frequently lift and/or move up to 25 pounds, and occasionally lift and/or move up to 100 pounds. Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, and depth perception.

While performing the duties of this job, the employee is regularly exposed to moving mechanical parts, to fumes or airborne particles, and outside weather conditions. The employee is occasionally exposed to toxic or caustic chemicals. The noise level in the work environment is moderate when working in the office and loud on-site inspections.
